ORDER N. 34 OF 20/03/2020

OBJECT: TRADE UNION ORDER. SUPPLEMENTARY MEASURES FOR CONTAINMENT AND THE MANAGEMENT OF THE EPIDEMIOLOGICAL EMERGENCY FROM COVID-19 IN THE TERRITORY OF THE MUNICIPALITY OF ISPRA.

THE MAYOR

Seen the D.P.C.M. of March 8th, 2020

Seen the D.P.C.M. of March 9th, 2020

Seen the D.P.C.M. of March 11th, 2020

containing the measures for the containment and to hinder the spread of the COVID-19 on the whole National territory;

In particular, given the measure that order to "avoid any movement of persons, except that for journeys motivated by proven work needs or situations of necessity or travel for health reasons. It is allowed to return to your place of living, home or residence";

Considering that the Municipality of Ispra is a territory that includes numerous "second homes" and accommodation used for short stays;

That on the municipal territory there is a population over 65, particularly relevant in numerical terms, resident and partly hosted in residential structures, where prevention measures related to the potential fragility of the subjects hosted there have already been applied;

It was deemed appropriate, in application of the precautionary principle, to reduce the creation of conditions that facilitate the spread of the virus through the adoption of some restrictive measures;

SEEN

- Article 50 of Legislative Decree 18-08-2000 n.267 and as amended;
- The legal regulations that attribute the competences to the Mayor as local health Authority in the field of hygiene and health;
- The restrictive measures already taken by the Ministry of Health;
- Article 54 of Legislative Decree 267/2000 and subsequent amendments

ORDERS

Within its territorial jurisdiction and with effect from March 20th, 2020 - until revocation of the present measure -

- to all subjects who are NOT resident, or resident but whose HABITUAL RESIDENCE is in other Municipality, that enter the Municipality of Ispra without justified reasons starting from March 20th, 2020 the obligation to report its presence on the municipal territory by contacting the Local Police Station poliziale@comune.ispra.va.it - 0332/7833300:

- to condominium administrators, to immediately communicate to all condominium residents and non-residents, the ordinance and obligation for those entering the Municipality of Ispra without justified reasons from March 20th, 2020 to report its presence on the territory by contacting the Local Police Station;
- to owners and managers of accommodation, hotel and non-hotel activities, to communicate immediately to their customers who enter the Municipality of Ispra without justified reasons that since March 20th, 2020 it is mandatory to report their presence in the area by contacting the Local Police Station;
- to all those who fall into the above cases NOT resident or resident in the Municipality of Ispra but habitually domiciled in another Municipality and present in the municipality without justified reasons from March 20th 2020:
 - to observe the stay-at-home order with fiduciary isolation for 14 days;
 - to observe the prohibition of journeys and travels;
 - to remain reachable for any surveillance activity;
 - if symptoms appear, notify your general practitioner immediately or the pediatrician of free choice or the public health operator territorially competent for each resulting determination.

The subjects falling under the aforementioned cases which entered the Municipality of Ispra on the days between March 8th, 2020 and March 19th, 2020 to report their presence to the local police station and to:

- observe the stay-at-home order with fiduciary isolation for 14 days;
- observe the prohibition of journeys and travels;
- remain reachable for any surveillance activity;
- if symptoms appear, notify your general practitioner or doctor immediately free choice pediatrician or the pediatrician of free choice or the public health operator territorially competent for each resulting determination (COVID-19 Emergency hotline 800894545)

ORDERS

- that when executing, supervising compliance with the provisions of this order and the Command is responsible for ascertaining and imposing sanctions Local Police Officer and any other police officer or judicial police officer authorized to do so by current provisions;
- that this order is valid until its express revocation and enters into force on time of its publication on the Municipal notice board.
- that this provision is made known to all citizens and bodies concerned, including through the media and posting in all public places in the area, currently open, to ensure its timely disclosure;
- that it is published on the Municipal notice board of the Municipality of Ispra.

The notice of this deed, in consideration of the circumstances, may also be sent by email

- to all owners and managers of accommodation, hotel and non-hotel activities in the Municipality of Ispra.
- to the Administrators of the condominiums of the Municipality of Ispra.

WARNS

That the violation of this ordinance implies the application of the sanction of art. 650 of the Criminal Code, being a contingent and urgent order;

That the Local Police and other Police forces are responsible for verifying compliance and execution of this act;

Anyone who has an interest against this provision may appeal, for incompetence, excess of power or violation of the law, to the competent Regional Administrative Court within 60 days of the publication of this Ordinance;

That the publication of this deed replaces the communication of initiation of the procedure to the interested parties, pursuant to law n. 241/1990 and subsequent amendments
